Minutes of Open Meeting Held on January 28, 2022

An Open Meeting of the Public Utilities Commission (Commission or PUC) was held Friday, January 28, 2022, at 1:00 P.M. in Hearing Room A, 89 Jefferson Boulevard, Warwick, Rhode Island to discuss, deliberate, and/or vote on the following dockets.

In attendance: Chairman Ronald Gerwatowski, Commissioner Abigail Anthony, Commissioner John Revens, John Harrington, Alan Nault, Todd Bianco, Emma Rodvien and Luly Massaro.

I. Chairman Gerwatowski called the Open Meeting to order at 1:00 P.M. A quorum was present.

II. **5215 – ServiceTitan, Inc. (Company)** - The Company applied for approval as a Class VI Telecommunication Supplier (VoIP services). The application included a request for confidential treatment of the Company’s financial statements. The Division filed a memorandum finding the application to be conformance with filing requirements and supported approval of the application.

Chairman Gerwatowski moved to approve the request for confidential treatment. Commissioner Anthony seconded the motion. The motion unanimously passed. **Vote 3-0.**

Chairman Gerwatowski moved to accept the Division’s recommendation to approve the application. Commissioner Anthony seconded the motion. The motion unanimously passed. **Vote 3-0.**

III. **Renewable Energy Resource Eligibility Applications** – The Commission reviewed and ruled on the applications submitted in the following dockets:

In the first four Dockets 5196 through 5199, listed below, PUC consultant recommended conditional approval of the applications subject to the applicant submitting documentation verifying achievement of commercial operation. Chairman Gerwatowski moved to accept PUC consultant recommendations to conditionally approved the applications. Commissioner Revens seconded the motion and the motion unanimously passed. **Vote 3-0.**

- **Docket No. 5196 – BD Solar Palmyra LLC’s** application for eligibility of the BD Solar Palmyra LLC generation unit, a 4.99 MW AC (7.0038 MW DC) solar facility located in Palmyra, Maine as a New Renewable Energy Resource.
- **Docket No. 5197 – BD Solar Hancock North LLC’s** application for eligibility of the BD Solar Hancock North LLC generation unit, a 7.0 MW AC

(10.159 MW DC) solar facility located in Hancock, Maine as a New Renewable Energy Resource.

- **Docket No. 5198 – BD Solar 2 LLC’s** application for eligibility of the BD Solar 2 LLC generation unit, a 6.999 MW AC (10.634 MW DC) solar facility located in Winslow, Maine as a New Renewable Energy Resource.
- **Docket No. 5199 – BD Solar Hancock LLC’s** application for eligibility of the BD Solar Hancock LLC generation unit, a 7.0 MW AC (10.159 MW DC) solar facility located in Hancock, Maine as a New Renewable Energy Resource.

In the next two dockets 5204 and 5207, PUC consultant recommended full approval of the applications. Chairman Gerwatowski moved to accept PUC consultant recommendations to approve the applications. Commission Revens seconded the motion and the motion unanimously passed. **Vote 3-0.**

- **Docket No. 5204 – TES Warwick Solar 23 LLC’s** application for eligibility of the TES02886SOLAR660RE generation unit, a .66 MW AC (.8127 MW DC) solar facility located in Warwick, Rhode Island as a New Renewable Energy Resource. Attached is PUC consultant recommendation to approve.
- **Docket No. 5207 – Commonwealth New Bedford Energy LLC’s** application for eligibility of the Greater New Bedford LFG Utilization Project generation unit, a 3.30 MW AC biomass facility located in New Bedford, Massachusetts as a New Renewable Energy Resource. Attached is PUC consultant recommendation to approve.

IV. **Docket No. 5189 – The Narragansett Electric Co. d/b/a National Grid** – This docket relates to the National Grid’s 2022 Annual Energy Efficiency Program Plan (Annual Plan). At this meeting, the Commission considered the Company’s Compliance Filing filed January 26, 2022. Noting that that PUC staff reviewed the filing and confirmed that the factors are correct, Chairman Gerwatowski moved to approve rate factors shown in Table G-1 and Table E-1 of the seconded revised compliance filing filed with the Commission on January 26, 2022. Commissioner Anthony seconded the motion and the motion unanimously passed. **Vote 3-0.**

V. Approval of Minutes of Open Meetings held on December 21, 2021. Chairman Gerwatowski moved to approve the minutes. Commissioner Anthony seconded the motion, and the motion unanimously passed. **Vote 3-0.**
