PUC 2-1 Supplemental

Request:

Bates page 335 of the 2021 Annual Energy Efficiency Plan features a list of each of the individual measures to be offered through the 2021 Gas Non-Income Eligible EnergyWise program and the expected number of units to be installed over the course of the program year. Please provide a table comparing the expected number of units to be installed vs. actual units installed for each of these measures.

Supplemental Response:

Please note that the Company’s initial response to PUC 2-1 only referenced the October 2020 planned units as reflected on Bates 335 of the 2021 Annual Energy Efficiency Plan. The planned spend (and correlating planned units) were adjusted in December 2020 based on Order No. 24225, ¶ 2,¹ which directed the Company to maintain the budget for the 2021 EnergyWise programs at the 2020 budget levels. The adjustment to planned spend (and correlating planned units) are reflected in the Company’s compliance filing dated December 23, 2020. See below table which shows the October 2020 and December 2020 planned units as well as actual units.
