## **NOTICE OF PUBLIC HEARING**

Pursuant to the R.I. Gen. Laws §39-3-11, as amended, the Public Utilities Commission (PUC) will conduct a public hearing on **Monday, December 19, 2022 at 9:30 A.M.** to examine proposals submitted by the Pascoag Utility District in the above captioned matter. The hearing will be held in Hearing Room A, at the PUC's office located at 89 Jefferson Boulevard, Warwick, Rhode Island. The hearing will be streamed live at <a href="https://video.ibm.com/channel/WqQyXw296dg">https://video.ibm.com/channel/WqQyXw296dg</a>.

The PUC will receive public comment from interested members of the public beginning at 9:30 A.M. on December 19, 2022. Interested members of the public can make comment in person or in a Zoom meeting through the internet or by calling in, preferably 5-10 minutes prior to the hearing. (The Zoom link will close at the expiration of the public comment period.) If you are not interested in providing public comment, please watch the live stream at the address in the first paragraph. You will be able to observe the hearing and hear others' public comment.

In Docket 22-40-EE, Pascoag Utility District submitted its Demand Side Management Program (DSM) for calendar year 2023 with an annual budget of \$216,777 to implement energy efficiency programs to its customers. The budget includes the continuation of the legislative mandated charge of \$0.0033 per kWh, pursuant to R.I. Gen. Laws §39-2-1.2(b), for application in the billing months of January 2023 through December 2023 to fund the DSM programs (of which \$0.003 supports DSM and \$0.0003 supports the Renewable Energy Development Fund). The DSM charge represents a monthly charge of \$1.65 on a typical residential customer using 500 kWh per month.

In Docket No.22-41-EL, Pascoag Utility District submitted proposed rate changes arising out of the reconciliation of its tariff adjustment provisions for the Power Supply Service, Transmission Charge and Purchase Power Restricted Fund Credit Reconciliation effective for consumption January 1, 2023. Specifically, Pascoag seeks to implement the following rate changes: 1) increase the Power Supply Service from \$0.064513 per kWh to \$0.068549 per kWh, 2) increase the Transmission Charge from \$0.039147 per kWh to \$.048506 per kWh, 3) increase the Purchase Power Restricted Fund Credit from (\$0.00214)) to \$0.0000. The combined net impact of the rate changes on an average residential bill with 500 kWh consumption per month, will result in an increase of \$8.27 or 10.2% per month, from \$80.70 to \$88.97. The impact on other customer rate classes will vary based on customer's rate class and usage. This includes the requested increase for the Demand Side Management increase requested In Docket No. 22-40-EE, which will increase from \$0.002000 to \$0.003000 per kWh.

As required by R.I. Gen. Laws § 39-1-27.8, Pascoag Utility District also included the utility's annual supply procurement plan for approval in this docket.
