Provide RGGI Bill Credits to A-60 Customers

On November 23, 2022, The Narragansett Electric Company d/b/a Rhode Island Energy (the "Company") filed with the Public Utilities Commission ("Commission") a tariff advice to create a new tariff for the purpose of governing the use of Regional Greenhouse Gas Initiative ("RGGI") funds to provide customer bill credits for A-60 rate class customers. The purpose of this memo is to provide the Division of Public Utilities and Carriers ("Division") comments on the filing.

The key points of the proposed tariff are as follows:

- Total available RGGI funds for bill credit: \$1.5M.
- Eligibility: Customers enrolled in the A-60 rate class during the November and December 2022 billing periods.
- The bill credit amount will be \$41.46.
- The bill credit will be included on bills issued in February 2023.
- If the total amount of bill credits is less than \$1.5M, the unused funds will be returned to the Office of Energy Resources.
- If the total amount of bill credits exceed \$1.5M, the Company will be allowed to recover the difference through the Revenue Decoupling Mechanism ("RDM").

The Division reviewed the proposed tariff and did not note any concerns. The only potential impact on the general body of ratepayers would be if the total credits exceeded the \$1.5M RGGI allocation. Even if this were to occur, the Division does not believe the amount would be sizable and any impact on rates would be minor since the excess would be recovered from all ratepayers through the RDM over 12 months. Based on our review, the Division recommends the Commission approve the proposed tariff as filed.
