Notice of Technical Conference and Public Participation

The Rhode Island Public Utilities Commission (PUC) will hold a Technical Conference on Thursday, February 9, 2023 beginning at 10:00 AM in Hearing Room A of the Public Utilities Commission Offices at 89 Jefferson Boulevard in Warwick, Rhode Island. On December 7, 2022, the PUC adopted a scope for this docket (Future of Gas) which can be accessed, along with other docket information at the docket webpage https://ripuc.ri.gov/Docket-22-01-NG. To begin the process, the PUC has invited panelists to speak about the future of the gas distribution system in Rhode Island and how to align emissions caused by the use of the gas system with the greenhouse gas emissions requirements of the Act on Climate. The full agenda for the meeting is provided below.

At this Technical Conference, the PUC will engage with the panelists about the topics described below. In addition, at the close of each panel there will be a process through which members of the public in attendance may submit questions to the PUC staff to be asked of the panelists. Whether all the questions can be addressed at this session will depend upon time available and number of questions submitted. However, the PUC notes this Technical Conference is not a public comment hearing. This is only the first Technical Conference of many which will take place in this docket, including at least one which will allow for public comment.

Panelists will discuss their expectations for the transition, including issues of timing, fairness, and reliability, as well as key concerns that

must be addressed.
