This letter is to notify you and others involved in the above-captioned proceedings of a change in the legal entity name of the applicant in these proceedings as well as a change in the name of the Project. Although the name of the applicant and the name of the Project have changed, no other elements of the Project currently being reviewed by the Rhode Island Energy Facilities Siting Board (the EFSB) have changed.

The applicant in this docket has been formally renamed to “SouthCoast Wind Energy LLC” (SouthCoast Wind) from Mayflower Wind Energy LLC. The Project that is the subject of the application currently before the EFSB in the above-captioned docket has been renamed to “SouthCoast Wind 1”.
