Request:

Refer to the Company's response to Division 2-6.

- a. Of the 1859 invoices pulled to conduct the Phase I out of period EE invoice investigation, how many relate to the Top 20 by year for the investigation period? In your response, please include the number and dollar value in each year for both the Top 20 and all invoices included in the investigation.
- b. For the "instances" identified in the Phase II investigation, how many relate to the Top 20 by year for the investigation period. In your response, please include the number and dollar value in each year for both the Top 20 and all "instances" identified in the investigation. For the definition of "instances", please refer to Company's report summarizing its review of invoices within the Energy Efficiency Program filed with the Commission of June 7, 2022, page 1, footnote 3.

Response:

- a. The Company used the "Top 20" document as a project management tool for the largest projects in the electric Large Commercial New Construction and Large Commercial Retrofit programs that are scheduled to complete within a calendar year. Phase I of the investigation reviewed invoices in the Residential Upstream Lighting Program. Therefore, none of the invoices reviewed would have related to the "Top 20."
- b. Phase II of the investigation identified four instances in the electric Large Commercial New Construction and Large Commercial Retrofit programs, included as Attachments PUC 3-4-2 and PUC 3-4-6. Attachment PUC 3-4-2 includes an email chain discussing projects from 2013, for which the "Top 20" document is not available. Attachment PUC 3-4-6 includes an email chain from 2016. Although this email includes discussion pertaining to the Large Commercial programs, no specific projects or customers are mentioned, so there is no way to cross-reference how these instances might relate to the "Top 20" document.
