### ALLEGED VIOLATION(S) OF DIG-SAFE (PLEASE CHECK)

1.  39-1.2-5(a) – Notice of excavation location was not given to the operator(s) of underground facilities or Dig Safe System, Inc. At least seventy-two (72) hours (exclusive of Saturday, Sunday, and holidays) but not more than thirty (30) calendar days before the proposed excavation.
2.  39-1.2-5(c) – If blasting was employed, the initial notification or subsequent notification did not indicate the date and specific location of the blasting.
3.  39-1.2-7(a) – The underground facility was not marked or was inadequately marked by the Operator of the facility.
4.  39-1.2-7(b) – The excavation area was not pre-marked prior to calling the association.
5.  39-1.2-8(a) – Requesting an emergency Dig Safe ticket when an emergency did not exist.
6.  39-1.2-10 – Excavation was not performed with precaution to prevent weakening of support to pipes, mains, wires or conduits or damage to the protective coating thereof and/or severance of any such pipe, main, wire or conduit. Attach support of allegations.
7.  39-1.2-11(a) – Damage occurred to underground facility and operator thereof was not contacted by excavator.
8.  39-1.2-11(b) – Any person, public agency or public utility shall report all suspected violation(s) of this chapter to the Division of Public Utilities and Carriers within thirty (30) days after learning of the circumstances constituting the suspected violation(s).
9.  39-1.2-12 – The marking of the underground facilities were lost or not maintained, and re-marking was not requested at least forty-eight (48) hours before the excavation began or continued.
