The projected annual revenue generated by the 2023 LIHEAP Enhancement surcharge using nine months of actuals through September¹ 2023 and estimates for October 2023, November 2023 and December 2023 is \$7,472,995. This amount includes electric-related revenue totaling \$4.86 million and gas-related revenue totaling \$2.61 million.
