Request:

Please provide a breakdown of billings (including totals) from Optimal Energy and its partners (the "C-Team") for work relating to the Three-Year Plan during 2023 (include estimated work through end of year).

Response:

Optimal Energy and its partners bill time associated with Three-Year Plan review under Task 1.2 — Implementation Oversight and Plan Development in their Scope of Work (SOW) with the Council. Task 1.2 encompasses a wide range of work streams beyond Three-Year Plan work. As a result, many of the C-Team's invoice entries under Task 1.2 include time that was not associated with Three-Year Plan work. For example, a member of the C-Team may spend two hours in a day on Task 1.2, with one hour spent on Three-Year Plan work and another hour spent on a sector team meeting. In responding to this request, the C-Team reviewed its billed work year-to-date and identified all entries that included work related to the Three-Year Plan. The C-Team then estimated the share of hours in 25% increments (i.e. 25%, 50%, 75%, or 100%) associated with Three-Year Plan work. The C-Team then rounded the estimated hours to the nearest quarter-hour increment to reflect its billing practices. Finally, the C-Team applied each staff's billing rate to the estimated hours to arrive at an estimated billing amount associated with Three-Year Plan work. The result of this review is presented in Table 1.

For the purposes of responding to this request, the C-Team considered "work relating to the Three-Year Plan" to mean resources spent on reviewing and providing feedback on the Three-Year Plan itself. Importantly, this means that works streams such as the Council's Priorities for the Three-Year Plan, Cost-Effectiveness Report development, Council meeting material development, and participation in this Docket were not considered in the development of the breakdown provided below. For this reason, the C-Team does not anticipate any additional work through the end of the year related to the Three-Year Plan. In total, the C-Team estimates 244.75 hours and \$40,976.50 have been allocated towards work related to the Three-Year Plan in 2023.

Request:

Please provide a breakdown of billings (including totals) from the C-Team for work on the Future of Gas docket (Docket No. 22-01-NG) during 2023 (include estimated work through end of year).

Response:

Optimal Energy and its partners bill time associated with the Future of Gas Docket under Task 3 — Regulatory Proceedings in their SOW with the Council. Task 3 encompasses work streams beyond the Future of Gas work. As a result, some of the C-Team's invoice entries under Task 3 include time that was not associated with the Future of Gas Docket. In responding to this request, the C-Team reviewed its billed work year-to-date and identified all entries that included work related to the Future of Gas. The C-Team then estimated the share of hours in 25% increments (i.e. 25%, 50%, 75%, 100%) associated with the Future of Gas Docket. The C-Team then rounded the estimated hours to the nearest quarter-hour increment to reflect its billing practices. Finally, the C-Team applied each staff's billing rate to the estimated hours to arrive at an estimated billing amount associated with work related to the Future of Gas Docket. The result of this review is presented in Table 2.

For work through the end of the year, the C-Team estimates an additional 15 hours and \$2,562.00. This estimate is based on the C-Team's expected participation in remaining Future of Gas Docket meetings, as well as an assumed level of effort to prepare for meetings and to continue providing input on work produced included in the Docket. Our total estimate for work related to the Future of Gas Docket, inclusive of estimated work through the end of the year, is 129.5 hours and \$24,370.75.

Request:

Please provide a breakdown of billings (including totals) from the C-Team for any non-energy efficiency related work during 2023 (include estimated work through end of year).

Response:

The C-Team, with few exceptions, considers nearly all of its work in support of the Council's role in providing oversight of energy efficiency programs delivered by Rhode Island Energy. For the purposes of responding to this request, the C-Team considered "non-energy efficiency related work" to apply to the following workstreams in 2023:

- All of the C-Team's work related to System Reliability Procurement under Task 2 in its SOW with the Council
- C-Team support on review and updates to the Council's By-Laws, provided under Task 5 in its SOW with the Council

Because Optimal Energy and its partners bill time associated with a variety of items under Tasks 5 that aren't related to what the C-Team has considered as "non-energy efficiency related work", the C-Team reviewed its billed work year-to-date and identified all entries that included work related to non-energy efficiency work. The C-Team then estimated the share of hours in 25% increments (i.e. 25%, 50%, 75%, 100%) associated with non-energy efficiency work. The C-Team then rounded the estimated hours to the nearest quarter-hour increment to reflect its billing practices. Finally, the C-Team applied each staff's billing rate to the estimated hours to arrive at an estimated billing amount associated with non-energy efficiency work. The results of this review are presented in Tables 4 and 5.

For work through the end of the year, the C-Team estimates an additional 1.5 hours and \$309.00. This estimate is based on the C-Team's expected remaining workload under Task 2 – System Reliability Procurement. The C-Team does not at this time anticipate any other non-energy efficiency related work. Our total estimate for non-energy efficiency related work, inclusive of estimated work through the end of the year, is 49.5 hours and \$9,810.50.

Request:

Referencing the Joint Pre-Filed Testimony of Samuel Ross and Craig Johnson filed on October 30, 2023 (Joint Testimony), please explain what the additional \$36,694.23 included in the proposed C-Team budget is for.

Response:

On July 28, 2022, the EERMC approved its proposed budget for 2023 which included an allocation of \$717,025.00 for its C-Team. On November 23, 2022, the Council filed a revision to its proposed budget for 2023 with the Commission in Docket 22-33-EE. The Council's allocation for its C-Team remained at \$717,025.00 in the revised budget proposal for 2023. At its Open Meeting on December 20, 2022, the Commission approved the Council's revised budget proposal for 2023, subject to the statutory cap contains in R.I. Gen. 39-2-1.2. This was later reflected in the Commissions' Report and Order in Docket 22-33-EE. During the course of the proceedings in Docket 22-33-EE, it was determined that the Council's proposed budget would in fact exceed the statutory cap contained in R.I. Gen. 39-2-1.2 by \$105,148.40. At its February 16, 2023 meeting, the Council voted to reduce its budget to be in line with the statutory cap. As part of this vote, the Council voted to reduce its budget for consultant services by \$36,694.23 from \$717,025.00 to \$680,330.77.

The additional \$36,694.23 included in the Council's proposed budget for consultant services for 2024 is simply restoring that portion of the budget that was reduced to ensure the Council's budget did not exceed the statutory cap. In other words, the Council's starting place for its proposed consultant services budget in 2024 was equal to its approved consultant services budget in 2023 (\$717,025.00) prior to the necessary reduction described above.

Request:

Referencing the Joint Testimony, Exhibit 9 includes a slide stating that he C-Team expects to "coordinate with OER to draft and issue RFP, evaluate proposals, and onboard a (potentially new) program administrator" and proposes a budget of \$100,000 for these activities. Please provide an explanation of how the EERMC arrived at the \$100,000 proposed budget. Please also provide an estimate of how much the C-Team expects to bill for each of the three categories of tasks, and a breakdown of any expenses incurred or expected to be incurred in 2023.

Response:

Explanation of Budget

The proposed value of \$100,000 for this work was an estimate informed by a combination of professional judgement from the C-Team, iterative review by the Council, and the Council's understanding of the nature and of the Council's anticipated involvement in the overall RFP process, pursuant to its statutory obligation to be 'in consultation' with OER. The C-Team provided a conservative (i.e. low) estimate relative to its experience conducting similar work supporting other clients in the process of procuring energy efficiency implementation services. In addition, as the issuance of an RFP for Energy Efficiency Implementation Services in Rhode Island is a new process for the state, this work area is subject to some uncertainty with respect to actual level of effort and time required, which is reflected in the 'round' nature of the \$100,000 estimate.

Expected Billing in Each Category

Because this task is new for Rhode Island, and involves many stakeholders, it is difficult to estimate a breakout of anticipated billing across the three categories of tasks, and the budget was not developed in a 'task-by-task' bottom-up manner. It is also worth noting that the categories "draft and issue RFP, evaluate proposals, and onboard a (potentially new) program administrator" were intended as illustrative examples of the type of work involved in efficiency implementation procurement support, not as an exhaustive list of all types of work that could be involved (some examples of additional work areas that are anticipated to potentially occur are included below). Rather, it was estimated as a substantial reduction from a total budget range that would typically be needed for this type of work. That said, it is the C-Team's understanding based on progress to date in this overall process that 2024 will likely have relatively limited billing associated with drafting and issuing the RFP, as much of that work is anticipated to be complete by the end of 2023. The breakout of time spent between proposal evaluation and onboarding support (and other work areas) may vary significantly depending on many factors that are currently unknown. Some examples of uncertainties in the process include: the number

of responses received; the nature of the review process (e.g. whether respondents will be interviewed); the degree, length, and nature of review of a proposed vendor's candidacy by various state agencies; the outcome of that process, including whether a new vendor or the incumbent is selected; the length of any contract negotiation and execution processes; and the amount of time that consequently remains in 2024 to begin onboarding in the event a new vendor is selected. Because of the manner in which this budget was estimated and the process uncertainty stemming from factors not within the Council's direct control, there is no expected breakdown of billing for 2024 among various tasks within this overall work area associated with the RFP.

Summary of Billing to Date

Optimal Energy and its partners bill time associated with this RFP process under tasks within its SOW that encompassed a range of work streams beyond its support in reviewing the RFP. As a result, some of the C-Team's invoice entries where this work appears may include work that was not related to support provided in the development of the RFP. In responding to this request, the C-Team reviewed its billed work year-to-date and identified all entries that included work related to support of this RFP. The C-Team then estimated the share of hours in 25% increments (i.e. 25%, 50%, 75%, or 100%) associated with support of this RFP. The C-Team then rounded the estimated hours to the nearest quarter-hour increment to reflect its billing practices. Finally, the C-Team applied each staff's billing rate to the estimated hours to arrive at an estimated billing amount associated with support of this RFP. The result of this review is presented in Table 8.

For work through the end of the year, the C-Team estimates an additional 8 hours and \$1,596.00. This estimate is based on the C-Team's expected additional work in reviewing draft RFP materials.

Our total estimate for work related to supporting this RFP, inclusive of estimated work through the end of the year, is 57.75 hours and \$11,584.75.

Referencing the Joint Testimony, the EERMC is proposing an energy efficiency and climate awareness campaign with a budget of \$85,000.00. Please explain what this program entails. Please also include an explanation of why this program is needed given other existing marketing efforts, including efforts by the Company and the Office of Energy Resources. Finally, please explain whether this proposal is a one-time program and expense or would be a recurring expense. If it is a recurring expense, please provide an estimate of future expenses after 2024.

Response:

Summary of What Program Entails

For this program, the Council is seeking proposals from qualified offerors to support the Council's responsibility of providing public education and outreach on energy topics. Specifically, the EERMC is seeking an entity to provide strategic marketing consultation, communication planning, and implementation of a public awareness campaign of energy efficiency's foundational role in addressing climate change and achieving the State's clean energy goals. The Council is seeking professional services for strategic consultation and marketing to foster greater public awareness of energy efficiency programming and solutions, and their role in reducing emissions across the state. The selected offeror will be responsible for developing and implementing a communications strategy to reach the public about the importance of energy efficiency improvements in the context of climate change mitigation.

The primary objective of this work is to enable the EERMC to better engage and support Rhode Island ratepayers in making informed energy and environmental choices. The EERMC envisions a multi-phased effort to develop and implement a public awareness campaign with key performance indicators to track success. Phase 1 would encompass tasks related to campaign development, including research and design. Phase 2 would encompass all tasks related to implementation of the campaign. Such efforts could include, but may not be limited to the following:

- Phase 1 Research & Design
 - Conduct literature review of relevant reports, policy, and resources (e.g., Nonparticipant Market Barriers Study, Act on Climate, etc.)
 - Conduct supplemental research if deemed necessary by the EERMC (e.g., focus groups, surveys, interviews, etc.)
 - Survey and build on existing efficiency and climate related outreach efforts in Rhode
 Island (e.g., Rhode Island Energy marketing campaigns)
 - Facilitate identification and honing of strategic objectives, target audiences, and key messages

- Conceptualize and design a public awareness campaign, likely including a variety of outreach elements and platforms such as video, web, social media, in-person events, print media, etc.
- Develop engagement goals along with systems and metrics for measuring and tracking engagement
- Phase 2 Implementation
 - o Implement the public awareness campaign developed in Phase 1
 - Integrate campaign with existing EERMC public outreach events (i.e., EERMC Annual Public Forum and Energy Lecture Series, Energy Expo at the RI Home Show)
 - Utilizing the key performance indicators established in Phase 1, evaluate and report on the reach, impacts, and outcomes of the campaign, including any recommendations for follow-up activities

Why This Program is Needed

One of the EERMC's statutory responsibilities, per R.I. Gen. 42-140.1-3, is to "promote public understanding of energy issues and of ways in which energy efficiency, energy conservation, and energy resource diversification and management can be effectuated." The need to address climate change is an urgent matter and the Council has a responsibility to help Rhode Island ratepayers understand how the rapidly evolving energy landscape impacts their lives and how they can benefit from available programs. Through the Act on Climate, the State has set mandatory and enforceable greenhouse gas emissions reduction targets, and energy efficiency improvements play a significant role in achieving those goals. The Council can help raise public awareness of the programs and services available to help reduce environmental impacts and emissions. In particular, the Council seeks to prioritize support for economically disadvantaged communities, which typically bear a greater burden with regard to the costs and impacts of a fossil fuel-based economy. In addition, energy efficiency is unique among climate mitigation efforts in that many of the solutions it offers include attractive customer economics, and significant societal benefits that accrue in addition to emissions reduction benefits. These features position efficiency as a least-cost solution for Rhode Islanders. Public education about this aspect of efficiency investments has the potential to save Rhode Island residents money relative to alternative strategies to pursue climate mitigation.

Program Recurring and Future Expenses

The Council's proposed budget for this item is currently contemplated as a standalone project and consequently is not considered a recurring expense. It is possible that the Council may wish to conduct follow-up work resulting from the delivery of this project as proposed for 2024. Any such follow-up work would be of a different scope and budget which the Council would include in future proposals beyond 2024.
