AlsoEnergy's software has an automated reporting feature to detect anomalies in meter data.

The verifier will enter this data into the NEPOOLGIS system and confirm this entry with the aggregation owner. The verifier has a dedicated reporting and support team to review and verify data who can report to the Commission.</p>

This fee would be a fixed price for service and unrelated to the number of NEPOOL GIS Certificates created.</p>
