

8. General Description of Registrant's operations:

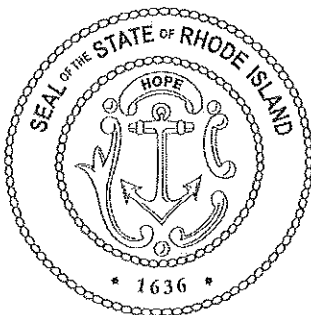
