NOTICE OF PUBLIC HEARING

Pursuant to the provisions of R.I. Gen. Laws §39-3-11, as amended, the Public Utilities Commission (PUC) is conducting an evidentiary hearing on **Thursday, March 20, 2025, at 9:30 A.M.** in Hearing Room A at the PUC's office located at 89 Jefferson Boulevard, Warwick, Rhode Island. The hearing may continue thereafter from time to time as required. A hearing for public comment was conducted on March 10, 2025. Any additional public comment may be emailed to Stephanie De La Rosa at stephanie.delarosa@puc.ri.gov. The hearing will be streamed live at <https://video.ibm.com/channel/WqQyXw296dg>.

At this hearing, the PUC will examine the Narragansett Electric Co. d/b/a Rhode Island Energy's proposed rate adjustments arising out of the Company's annual reconciliations of Last Resort Service (LRS), LRS administrative costs, the non-bypassable transition charge, transmission service, the Net Metering charge, and the Long-Term Contracting (LTC) for Renewable Energy Recovery Factor. The PUC may also examine the proposed Last Resort Service rates for residential and certain commercial customers for rate periods commencing April 1, 2025. In addition, the PUC may examine the proposed Renewable Energy Standard Charge and Reconciliation of prior period costs that are included in Last Resort Service rates. All rates being reviewed in these dockets have a proposed effective date of April 1, 2025.
