Because this is not a hearing, the PUC will not be accepting oral public comments. - **I.** Call to Order
- II. Docket No. 24-50–REG The Narragansett Electric Co. d/b/a Rhode Island Energy (Company) This docket relates to the Company's 2025 Renewable Energy Growth (RE Growth) Program approved by the Commission in this docket. In accordance with R.I. Gen. Laws § 39-26.6-20(b), the Company selected nine (9) medium scale solar projects, two (2) commercial scale solar I projects, one (1) commercial scale solar II project and one (1) small scale Hydropower project in the Third Enrollment RE Growth Program Open Enrollment. The Company requests approval of the Certificate of Eligibility (COE) for the commercial scale solar projects. The Commission will review the filing and vote on the Company's request.
- III. Docket No. 25-36-EL The Narragansett Electric Co. d/b/a Rhode Island Energy (Company) This Docket relates to the Company's Tariff Advice filing that will govern the utilization of Regional Greenhouse Gas Initiative (RGGI) Bill Credits to A-60 Customers in 2025. On October 15, 2025, The Division filed a memorandum stating that the proposed tariff is reasonable and consistent with prior Commission approved tariffs that governed RGGI funds to eligible A-60 customers and that approval is recommend for the tariff as filed. At this Open Meeting the Commission will review the filing, and a vote will be taken.
- IV. Consent Agenda All items listed within the Consent Agenda are to be considered routine by the Commission and will ordinarily be enacted by one motion. There will be no separate discussion of these items unless a member of the Commission requests, in which event the item will be removed for separate consideration later on the agenda. As noted below, the agenda includes applications for authority as a Telecommunications service provider and applications for eligibility as a Renewable Energy Resource and PUC consultant's and Division's recommendation on the applications.

25-39-TL	Verizon Rhode Island	Verizon RI's Tariff filing proposes an increase of the monthly rate for residential packages. On October 20, 2025 The Division filed a memorandum recommending approval of the proposed amended tariffs as filed to take effect November 1, 2025, and to grant Verizon RI's request for confidential treatment of its commercially sensitive information.
RES-25-55	Admiral Packaging, Inc	Application for eligibility of the Admiral Packaging Inc. Solar Generation Unit, .220 MW AC (.2496 MW DC) solar energy facility located in Providence, Rhode Island. PUC consultant recommends approval.
