Q. Are you the same Kevin McDonald who filed direct testimony and rebuttal testimony in this Docket

A. Yes, I am.

Q. What is the purpose of your supplemental rebuttal testimony?

A. The purpose of my supplemental rebuttal testimony is to clarify my rebuttal testimony filed on November 19, 2025. In my rebuttal testimony, I referenced the "... proposed increase in debt service coverage from the current 1.25% to 1.30%." To clarify, and to be consistent with my direct testimony, this references the fact that current debt service coverage is 1.25 times the annual debt service and the proposed coverage increase is 1.3 times the annual debt service.

Q. Does this conclude your supplemental rebuttal testimony?

A. Yes, it does.
