With this filing, Verizon Rhode Island ("Verizon RI") proposes to withdraw the following services from the tariff in wire centers where Verizon continues to migrate its network to all fiber and retire its copper network. The Rhode Island Public Utilities Commission previously allowed the withdrawal of these same products in other wire centers where Verizon is migrating to an all fiber network.

- WATS Access Line (WAL)
- Feature Group A (FGA)

As previously communicated, Verizon is engaged in a multi-year program to update select wire centers to next generation operating equipment including wire centers listed in Attachment 1. Verizon will discontinue certain Intra-State Switched and Special Access private line DSO services as well as certain Intra-LATA DSO services in the wire centers on or after November 13, 2025, subject to regulatory approval where required. The state-specific names for these services are shown in Attachment 2.

According to our records, you currently subscribe to at least one of the services referenced above.

<u>Verizon will provide you with subsequent notice at least 90 days in advance of the actual date that your services will be disconnected.</u> You may have received disconnection notifications for segments of this circuit at other locations. If you have a point-to-point service, the segment with the earliest disconnection date will serve as the disconnection date for the entire point-to-point service.

Modifications in service offerings for customers with existing contracts are subject to the terms of their contract, including any tariff or product-guide provisions incorporated into the contract.

At this time, please review your applications that use these services and determine whether you wish to migrate those applications to an alternative Verizon product or to another provider.
