Now comes Mission:data Coalition ("Mission:data") and objects to the Motion To Strike Testimony filed by the Narragansett Electric Company d/b/a Rhode Island Energy ("Rhode Island Energy").

On December 5, 2025, Mission:data filed its direct testimony in the above captioned Docket. On December 12, 2025, Rhode Island Energy filed its motion to strike regarding Mission:data's direct testimony. This motion was filed five days before the December 17, 2025 hearing originally scheduled in this Docket. On December 15, 2025, the Rhode Island Public Utilities Commission ("Commission") canceled the December 17, 2025 hearing and instead scheduled oral argument on Rhode Island Energy's Motion To Strike Testimony.
