Dear Hearing Officer Harrington,

On behalf of Charter Communications, Inc., Cox Enterprises, Inc., and Cox Communications, Inc. (“Joint Applicants”), I write to respectfully request that as part of the review and approval of the transfer of control over Cox Communications, Inc.’s subsidiary, CoxCom, LLC, from Cox to Charter, the Division update the entity name reflected on CoxCom’s Certificates of Authority to Operate and the related Certificates of Construction and Compliance Order Certificates (“Certificates”) from CoxCom, Inc. to CoxCom, LLC.

The requested update does not reflect a change in the name of CoxCom as a result of the proposed transaction between Charter and Cox. Instead, the update relates to the conversion of CoxCom, Inc. from a Delaware corporation to a Delaware limited liability company in 2011. The entity holding the certificates remains the same entity. However, it appears that at the time of the conversion, the name change was not updated on the Certificates. The Joint Applicants therefore request that the Certificates be updated to conform to the proper entity name of CoxCom, LLC.

In support of their request, the Joint Applicants provide a copy of the Delaware Secretary of State’s Certificate of Conversion of CoxCom, Inc. to CoxCom, LLC.

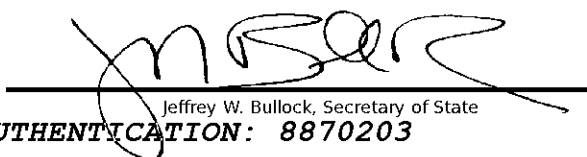

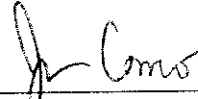
