RR-1: Provide a definition of “induced jobs” as stated on Page 15 of QDC/GDQ Exhibit 3.

Response: Page 15 of QDC/GDQ Exhibit 3 references direct, indirect and induced jobs. Direct jobs are employment on the construction and operation of the project itself as identified in the Application and Siting Report submitted to the EFSB in this Docket (“Project”). Indirect jobs would be those that support the needs of the Project, such as materials, supply chain, transportation, and other support services. Induced jobs are employment positions related to spending by those in direct and indirect jobs. For reference, the induced jobs effect has been defined as follows:

“A construction worker building a new facility spends wages on groceries, utility bills, mortgage payments, and entertainment. These expenditures support grocery store employees, utility workers, bank staff, and restaurant workers, who then spend their earnings, continuing the cycle.”

Response: Attached please find the following:

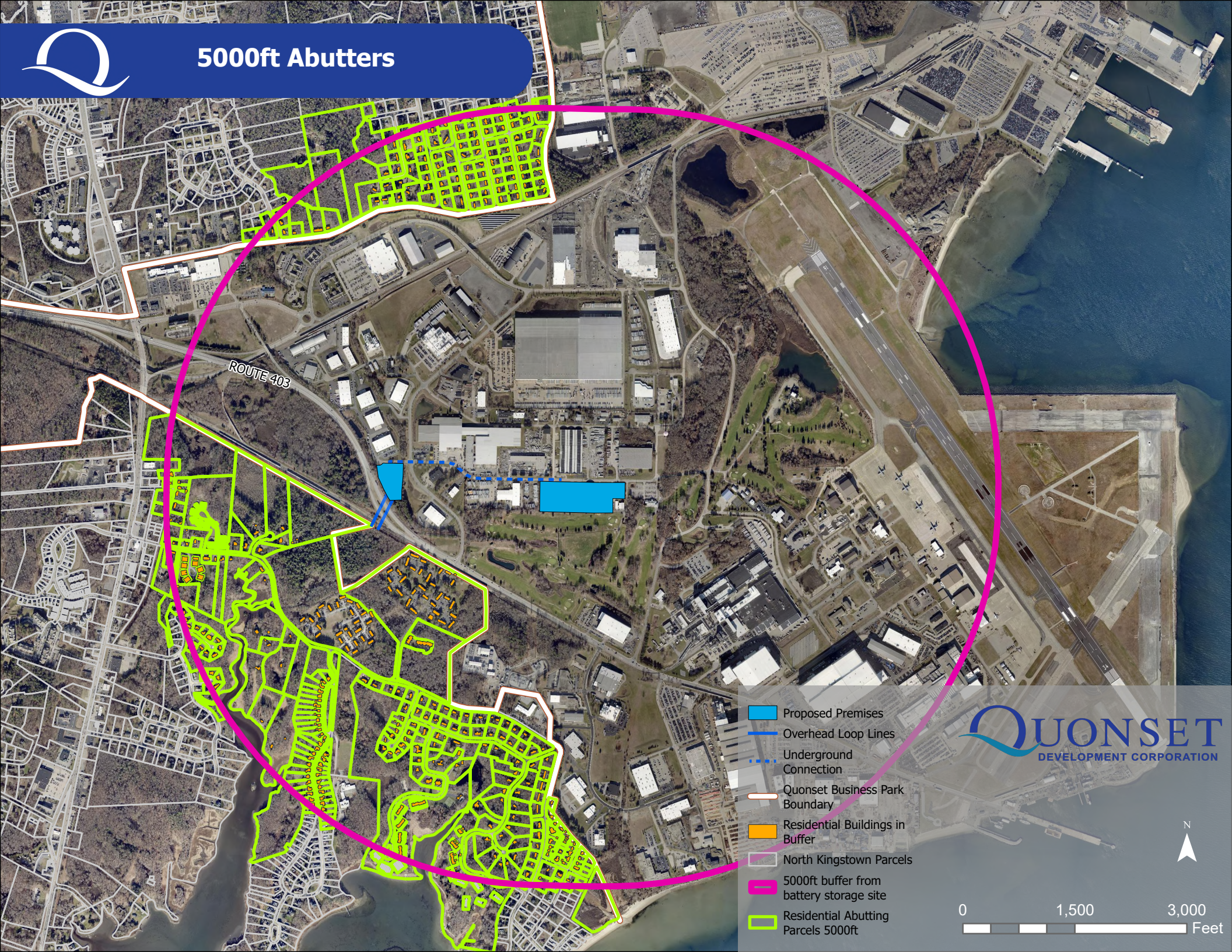
1. 5000 foot Radius Map from the battery storage units.

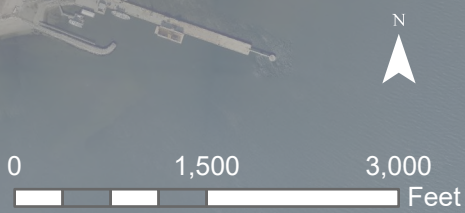
5000ft Abutters
