Re: Request for the "reasonable rules and regulations governing the procedure to be followed in any matter that may come before it for a hearing" per Section § 39-1-11

Mr. Lanni,

I received my bill for services today and it is unreasonable and uneconomical, and thus unlawful as a violation of State Policy- see R.I.G.L Section 39-1-1a (3). Per my phone message, I would like to formally request a published copy of the "reasonable rules and regulations governing the procedures to be followed in any matter that may come before [the PUC] for a hearing" per Section § 39-1-11

My intent is to call several witnesses, including members of the Public Utilities Commission (PUC hereafter), members of Narragansett Electric Company (NEC hereafter), and one expert witness from the Boston Area to testify on various statements made to me, billing matters of the NEC and "Policy B" interpretations both in my case and in prior cases involving the supply and billing for electric power on PUBLIC ROADS in Rhode Island. In addition, I will need documentation from the PUC and NEC covering all the aforementioned, as well as all documentation which justifies and explains the charge of \$8.80 per foot and any documentation which explains the PUC's review and approval of this amount.

Lastly, it is my intention to explore my good faith belief that the current membership and relationships as developed between the PUC and NEC breaches the statutory requirement of an "independent and impartial" body, so I will need the full and complete resumes of all current and recently employed and appointed staff of the PUC which deal with the NEC on a regular basis, as well as the complete resume of any "Hearing Officer" in this matter.

It is my intent to call at this time the following witness. If I need to make further arrangements for their appearance please let me know.

Re: Installation of line extensions on Public Road


Mr. Lanni,
