- 2) Please identify the amount of finance charges incurred by NBC by accepting credit card payments from customers in FY08.

The NBC paid credit card fees of \$58,387.63 in fiscal year 2008.

- 3) Please identify the work load and tasks to be assigned to the Customer Service Field Investigator position requested by NBC in this Docket.

NBC's Customer Service Section is responsible for the accurate and timely billing and collection of more than 83,000 customers. The NBC receives meter readings from seven different water suppliers and uses these readings as the basis for the consumption bills. The Field Investigators perform many critical functions within the Customer Service Section. The following is a list of tasks performed by the Field Investigators:

1. NBC runs reports to determine the accounts that have not had meter readings within the last 3 months. NBC also runs edit reports related to readings where the meter does not match the meter on file. The Field Investigators perform research on the water supply board computer systems, at the water supply boards and make site visits in order to obtain meter readings. The Field Investigators have laptop computers and directly enter the meter readings along with any notes into the billing system.
2. The Field Investigators make site visits to NBC's large customers prior to billing to obtain actual meter readings. This includes accessing meter pits and confined space entry. The Field Investigators also work closely with customers that have multiple properties and meters such as Brown University, RI Hospital, Providence Housing, Providence Schools, and the Rhode Island School of Design to ensure all meters are billed and that meter readings are accurate.
3. NBC's Field Investigators perform dye tests to determine if premises are in fact connected to NBC's sewer system.
4. The Field Investigators are automatically assigned accounts that have transactions that are disputed by a customer. In most cases this results in a site visit. Types of disputed transactions include high meter out readings, leaks where customer claims that the water was not returned to sewer, correction to user classification, inactive accounts, dead meters, meter reading corrections, etc.
5. NBC has an abatement program and the Field Investigators must review the abatement applications, follow-up on applications to ensure proper meter installation and to obtain meter readings.
6. The Field Investigators also assist with the research of returned mail. NBC receives nearly 5,000 pieces of returned mail annually which have to be researched to locate the property owner.

7. New meters and new accounts must also be researched. If NBC receives a meter reading for a customer not on file, the account is assigned to a Field Investigator to determine if a meter has been replaced or if a new account must be added (see attached sample report). In addition, Field Investigators must visit the various town halls to research property records and determine ownership as well as research new connections to the NBC sewer system. Drive-bys of new subdivisions are also conducted to determine whether or not properties with sewer connection permits have actually connected to the NBC system and should be billed.

The table below shows some of the statistics for the Field Investigator activities during this fiscal year.

6. The Field Investigators are also integral to NBC's collections. As part of its collection efforts, NBC uses both lien sale and water service termination. The Field Investigators drive by all of the properties selected for lien sale to assess the condition of the property and determine whether or not the structures are boarded or have been demolished. This involves 700-800 properties each year.

With respect to water termination, NBC's upgraded customer service application gives NBC the ability to update the list of accounts eligible for water termination on a "rolling" basis. The Customer Service Manager can then initiate the water termination process daily compared to the prior method which batched approximately 300 accounts that were worked from start to finish. Each account that remains unpaid during the water termination process must be physically posted by the Field Investigators. Prior to posting, the Field Investigators plot out their route on gps to obtain the most efficient route. They work in pairs with one driving and the other posting the property. Water shut-offs take place throughout NBC's service area. A NBC Field Investigator also accompanies the water supplier to all water terminations.

The chart below shows the increase in workload related to the water termination (WSO) process. The number of accounts posted for WSO has

increased 476% since FY 2004 and the number of accounts shut off has increased by 468% over this same period.

The table below shows the effectiveness of the water termination process as a method of collection. The amount collected through WSO increased more than 700% from FY 2004 and the amount budgeted has increased more than 500%.

Increased Workload

Over the past several years, the number of field investigations has increased significantly. The table below shows that since FY 2005, the number of accounts investigated has increased by 390% while staffing has remained level. Based on four Field Investigator positions, the number of investigations per week per FTE has increased from 15 to nearly 60.

Conversion to Monthly Billing

With the conversion from quarterly to monthly billing, the number of bills mailed and payments processed from approximately 320,000 to more than 960,000. Since actual meter readings are not available from the seven different water suppliers on a monthly basis, NBC will estimate consumption based upon prior usage and then “true-up” the consumption once an actual read is received. The Field Investigators will play a critical role in this process by ensuring that the most current and accurate meter readings are on file. This, in turn, will ensure that customers will receive accurate bills and that their estimated consumption will be “trued-up” as efficiently as possible. The new position will support the field research, dispute investigation, customer inquiry and input of meter readings with the more frequent billings.
