It was a pleasure chatting with you yesterday. As discussed I am not in favor the the wind farm off the coast. I know several people in and around the industry and they have told me that, while noble in theory, solar and wind energy have a severe drawback. So, here is my big question. How long does it take to get a payback on initial investment? How long before regular maintenance is required? I understand in most cases, maintenance is required significantly sooner than the pay back period. In other words, without government subsidies, these things don't pay for themselves.

I am sure studies have been done on turbines located on dry land. The investment required to build and maintain turbines in a marine environment have to be several times higher.
