Dear Mr. Voigtsberger,

Our firm represents Mr. and Mrs. Green and the Deanna's Lyric Foundation. You are hereby directed to cease communicating with our clients directly but rather direct any future communication to our law firm alone.

Your e-mail communications to Mr. Green on September 7, 2012, followed by the attached e - mail communication dated September 10, 2012 were insensitive, inappropriate and "unseemly" at best.

The Green family has lived through an unimaginable tragedy, the loss of their young child. Their purpose and mission to protect others from suffering similar tragedy is a most noble and courageous crusade.

The Green's purpose is not to "vet" your contact voltage detection tool, a task best left to the "experts" while, at the same time, we recognize that its failures and deficiencies are well documented by utilities and third parties in the supplement provided with the August 31, 2012 letter from Mr. and Mrs. Green.

Distributing a denigrating “public” document in an attempt to harass, intimidate, and pressure the Greens into endorsing or supporting your business, does not change the fact that well documented data and information which are part of the “official record” must not and cannot be ignored by those responsible for the safety of the public.

Your frustration with the present situation or deficiency of your product provides no excuse for “fighting” with the Green family, the Lane family, and other families who have lost loved ones to contact voltage.

As to the balance of your demands, allegations, and “self-serving” statements, it is not our purpose to and is not our client’s responsibility to engage with you.

Please address any comments you have to the proper officials and leave our clients alone as they have the right and they feel the obligation to protect the public.
