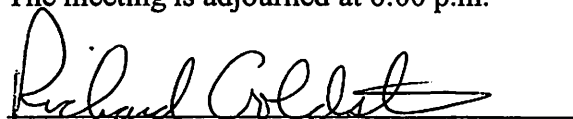

AN ORDINANCE REGARDING THE PAYMENT OF HYDRANTS RENTAL USAGE OR FEES.

Mr. DeCelles states that there will be a \$30.80 charge per year per meter if the hydrant fees are transferred from the taxpayers to the ratepayers. He explains that most multi-family houses have one meter and if that is the case, then there will be only one charge for the entire house. He states that if this is approved it will have to go to the Public Utilities Commission for approval of a tariff, which should take 30-45 days.

Councilor O'Neill asks if the Pawtucket Water Supply Board could reduce expenses to offset the \$560,000 in hydrant fees.

Mr. DeCelles says no, it would need to go to the Public Utilities Commission.

Councilor Hodge states that the fee would have to be doubled this year if they begin collecting in January.

Councilors Barry and O'Neill state that they are concerned about Pawtucket residents paying double because the fee is already in the city budget..

Mr. Pires states that the Administration agrees with cutting the Pawtucket Water Supply Board's budget to offset the revenue lost this year.

Mr. Pires states that for the budget process to work, the Administration manages the budget and the City Council oversees the process. He notes that the budget has a \$1.4 million lag that needs to be resolved. He does not think that the hydrant bill will be double dipping because the budget savings will be used to fill the lag.

Councilor Hodge states that he is concerned about Cumberland and Central Falls subsidizing the hydrant fee cuts if they don't ask Pawtucket ratepayers to pay it, but rather make up for the lost fees through budget cuts.

Upon motion made by Councilor Tetreault, seconded by Councilor Barros, the Committee recommends submitting this ordinance to the Council without a recommendation.

Mr. Giron states that he filed a tax appeal based on the property's actual value of \$50,000.

Mr. Giron states that Mr. Savage is willing to pay taxes since he owned the property in 2009, but not back to 2006 for which Mr. Savage has received bills, and based on the fair market value.

Ms. DiGiuseppe states that Mr. Savage bought this property at tax sale in 2006 and perfected his ownership in 2008.

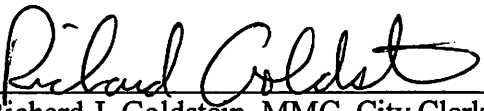

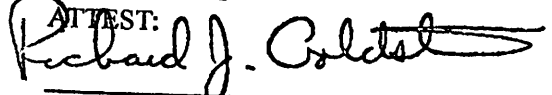

NE Infrastructure requests a change order for work being done at Robin Hollow Dam improvements. The total cost change is equal to \$569.22 for :

- Additional material and construction costs involved in the installation of three 48 inch temporary by-pass lines (Option 1) that are used to divert the reservoir water downstream of the spillway construction work area . Additional cost of \$50,569.22
- The lowering of the reservoir revealed that the upstream area in front of the spillway contained heavy growth of aquatic plants extending from the pond floor to the ponds water surface. Due to this

Comm. 1-5: Please provide the number of meters by meter size.

Response: The original filing indicated there were 17,418 meters in the City of Pawtucket. However, there were 14 meters with missing data codes of IN (for inside Pawtucket) or OUT (for outside Pawtucket). Following the filing of the Tariff Advice, each account was inspected and all 14 meters are located in Pawtucket. Therefore, the actual meter count in Pawtucket is 17,432. (See Attached). This does not change the PWSB's request for a \$2.57 Fire Service Protection Charge.

To collect the \$535,768.43 of lost revenue from 17,432 meters, the actual charge would be \$2.560833333.¹ The PWSB still recommends that the proposed charge be rounded to \$2.57, which provides an excess of \$1,834.45.² If the PWSB rounded down to \$2.56, it would under-collect by \$257.39.³ The excess will provide the PWSB with a cushion as there could be some collection issues, and if the excess is collected, the PWSB still recommends that it be deposited to the restricted IFR account.

Comm. 1-6: Did PWSB's analysis of the allocation of the Fire Protection Surcharge among meter sizes go beyond the determination that 97% of the meters were 1 inch or less? If so, please provide the remaining analysis.

Response: The PWSB analysis of the Fire Protection Surcharge did not go much further than the analysis of meter distribution. As set forth in the attachment to Comm. 1-5, 97% of the meters in Pawtucket are smaller than one inch. Based on the meter distribution, an increase in the amount of the surcharge on large meters would have to be very severe and to make any significant impact on residential customers. The PWSB believes this would be inequitable.
