Quarterly Report – 4th Quarter FY 2014**

Dear Ms. Massaro:

On behalf of National Grid,¹ I am writing to inform the Rhode Island Public Utilities Commission (the “PUC”) that the Company will include the information that it provides in its quarterly report for the fourth quarter of FY 2014 (“Fourth Quarter ISR Report”) regarding the Company’s Electric Infrastructure, Safety, and Reliability (“ISR”) Plan for FY 2014 (“ISR Plan”) in its electric ISR Plan FY 2014 Annual Report and Reconciliation, which is due to the PUC by August 1, 2014.

Pursuant to the approved ISR Plan, the Company committed to providing quarterly reports on the progress of its electric ISR Plan programs to the PUC and the Division. The Company typically attempts to file its quarterly reports approximately 45-60 days following the end of each quarter of the fiscal year ISR Plan period ending March 31. The Company is still reviewing specific accounts and financial statements for the fiscal year ended March 31, 2014, the first full fiscal year processed under National Grid’s newly implemented general ledger system, which went “live” in November of 2012. The Company’s intent in delaying the provision of the information that is normally included in its Fourth Quarter ISR Report is to ensure that all data submitted has been fully and comprehensively reviewed and validated and to avoid any potential for required revision that a premature submission might produce. The Company will complete this effort no later than the time that the Company files its electric ISR Plan FY 2014 Annual Report and Reconciliation, which is due to the PUC by August 1, 2014. Therefore, rather than provide the PUC and the Division with duplicative reports, the Company plans to include the Fourth Quarter ISR Report information in its FY 2014 Annual Report and Reconciliation filing in this docket.
