

KENT COUNTY WATER AUTHORITY'S OBJECTION TO
PROVIDENCE WATER SUPPLY BOARD'S COMPLIANCE FILINGS


Kent County Water Authority ("KCWA") hereby objects to any untimely submittal of Providence Water Supply Board's ("PWSB") Compliance Filings to this tribunal. In the instant matter, at the February 10, 2017 Opening Meeting, the Public Utilities Commission ("PUC") ordered PWSB to submit its compliance filings no later than February 14, 2017. Pursuant to Rule 1.6 of the RI Public Commission's Rules of Practice and Procedure, the date established in the PUC's order shall be the last day of the period so computed, which in this case is February 14, 2017.

KCWA submits that the purpose for establishing the compliance filings submittal date was to allow all parties adequate time to review and analyze them prior to the Open Meeting scheduled for 11:00 AM on February 16, 2017. Without the opportunity to properly analyze any compliance filings, KCWA as well as all other Parties are precluded from having adequate time to formulate and submit any responsive filings with the PUC prior to the February 16, 2017, Opening Meeting. As a result, KCWA is prejudiced from forming any position on the untimely Compliance Filings which will directly affect its wholesale rate.

For these reasons, KCWA respectfully objects to any untimely Compliance Filings by PWSB and further moves the PUC to grant its objection and any further relief that may be deemed appropriate.
