PUC 1-2

Request:

Referencing slides 11 and 12 of the January 11, 2017 power point, please confirm the amount that will be credited (a) to the host customer and (b) to the recipients.

Response:

Referencing the example shown in slide 11 of the Company's January 11, 2017 PowerPoint presentation, identified as Attachment PUC 1-2, a Renewable Net Metering credit of \$127.11 is applied to the host customer's bill for this billing period. This amount is used to offset other charges billed to the host customer, which, in this example, is the Customer Charge and LIHEAP Enhancement Charge, resulting in a net credit of \$116.28 that is available to be transferred to the recipient accounts. Allocating the credits as shown on Page 12 would result in the following:

Recipient 1 (50%):	\$58.14
Recipient 2 (25%):	\$29.07
Recipient 3 (25%):	\$29.07
Total Transferred:	\$116.28

2016 Changes to Net Metering



- Recent legislation in Rhode Island includes several important revisions to the net metering law (R.I. Gen. Laws Sections 39-26.4-2 and 39-26.4-3)
- Per the new law, in Docket No. 4631, the PUC approved the Company's revised Net Metering Provision (RIPUC No. 2169, effective August 12, 2016) to include the following provisions:
 - Third-Party Ownership of net metered systems
 - Maximum system size increased from 5MW to 10 MW
- Law also includes 30MW community net metering (CNM) pilot, which will be implemented between now and 2018 and allow residential customers and low-moderate income (LMI) housing eligible to receive net metering credits from remote systems

CNM Pilot – Eligibility Requirements for Credit Recipients



- CNM systems must designate at least three eligible recipients, or at least one recipient if that recipient is a LMI housing unit
- There is no maximum number of credit recipients
- For Residential recipients:
 - No more than 50% of the net metering credits may go to one recipient
 - At least 50% of the net metering credits must go to individual customers in amounts no greater than the annual kWh produced by a 25 kW AC system

CNM Pilot – Threshold Criteria



- The CNM Pilot is capacity limited and provides a valuable right. Therefore, National Grid proposes that applicants must meet the following threshold criteria to qualify for the pilot:
 - Interconnection application must be made, and a valid Impact Study for Renewable DG (ISRDG) or a valid Interconnection Service Agreement (ISA) must be in possession -- this step includes evidence of site control
 - A Performance Deposit equal to \$25 per MWH to be produced annually by the project must be provided to National Grid, up to a maximum of \$75,000, which will be refundable in the year after commercial operation is achieved
 - Projects in the queue will have 24 months to reach commercial operation and meet the requirements of the CNM pilot statute after which they will lose their status in the CNM queue
- These criteria were proposed and supported by solar industry groups as part of the stakeholder process sponsored by OER

CNM Pilot – Application Process



- Applicants apply to National Grid for interconnection and receive completed ISRDG and/or a valid ISA, as applicable
- Projects seeking to serve an LMI customer account must receive written approval from Rhode Island housing prior to enrolling the project with National Grid
- Applicants with completed study then provide Performance Deposit, and Schedule B with any eligibility letters for LMI participants from RI Housing
- National Grid will provide confirmation of the queue allocation to the project and a commercial operation deadline date 24 months from confirmation
- Applicants must adhere to all deadlines, and pay required costs on time
- Prior to the Company's determination that a project is ready for commercial operation, all eligibility requirements must be met, with eligible recipients designated on Schedule B

Eligibility as a Low or Moderate Income (LMI) Property



In order to be eligible as a LMI Property for participation in the Program, each of these requirements must be met:

- Be assisted under federal, state or municipal housing program
- Be subject to a deed restriction with an original term of 30 years, (i) limiting occupancy of at least half the units to households below 80% of area median income, and (ii) sets rents at an amount affordable to a tenant at the 80% level
- Agreement that 50% of the net value of the credits be used to provide benefits to the tenants of the property

RI Housing Application Requirements for LMI Review



Materials to be submitted to Rhode Island Housing:

- Description of the housing assistance program
- Unit count, and number of units set aside for low or moderate income residents
- Deed restriction for the property
- Rent schedule
- Anticipated Net Value of the Credits
- Description of how a portion of the Net Value will provide benefits to the tenants
- Non-refundable application fee of \$200
- Signed certification of authorized representative regarding obligation to annually demonstrate benefit to tenants

Sharing Benefits with Tenants



LMI Properties are encouraged by RIH to propose creative approaches to direct 50% of the Net Value of the credits to benefit tenants, which is required by the statute. Possible approaches include:

- Rebate of rent
- Provision of free or reduced-charge high speed internet access
- Provision of social service programs, such as job training or financial literacy programs
- Installation of energy-savings programs for the property
- Establishment of additional operating or replacement reserve accounts to safeguard the physical and financial condition of the property

CNM Pilot – Transfer of Credits



- CNM system must provide information regarding credit recipients on Schedule B prior to commercial operation
- Schedule B must include:
 - Estimated generation in kWh of the Net Metering System
 - 3-yr annual average kWh use of the net metered accounts
 - Percentage of generation to be applied to each net metered account
- Updates to Schedule B will be allowed quarterly until a self-service, on-line process is implemented

CNM Pilot - Applications of Net Metering Credits for Remote Systems



- Net Metering credit is based on the rate class of the Host Account (generator)
 - “Stand-alone” generators are placed on Rate C-06 – Small Commercial
- Credit (Rate C-06) is calculated as:
 - Distribution (Base, ISR, RDM): \$0.03852 per kWh
 - Transmission: \$0.02566 per kWh
 - Transition: (\$0.00058) per kWh
 - Standard Offer : \$0.08108 per kWh
(Base, SOS Adj, SOS Admin):
 - Total: \$0.14468 per kWh

Note: Reflects rates in effect as of January 1, 2017

CNM Pilot - Applications of Net Metering Credits for Remote Systems (continued)



- The total net metering credit is multiplied by the number of kWh exported over the billing month.

CNM Pilot – Applications of Net Metering Credits for Remote Systems (continued)



- If CNM system annual output exceeds the aggregate 3-yr annual average use of all recipients, the Company will make an adjustment to the CNM system account
 - Generation that is between 100% and 125% of on-site use valued at Standard Offer Rate
 - Generation in excess of 125% of on-site use has no value

From 39-26.4-2.: The community remote net-metering system may transfer credits to eligible credit recipients in an amount that is equal to or less than the sum of the usage of the eligible credit recipient accounts measured by the three (3) year average annual consumption of energy over the previous three (3) years. (*Emphasis added*)

CNM Pilot – Other Issues



- Interconnection queue information is already posted regularly on the Company's website, consistent with changes the Company made to its Distributed Generation Interconnection Tariff
- Once the CNM Pilot is approved, on a monthly basis, the Company will post and update information regarding remaining queue availability for the Pilot on the RI Net Metering webpage
- These changes will be made via a standard Schedule B in electronic form that will be provided by National Grid, and which system owners will be able to submit to the Company once per quarter

The Company uses the Standard Offer Service rate, not including the Renewable Energy Standard Charge, applicable to the net metering customer (i.e. billing account associated with the generator) to calculate the Excess Renewable Net Metering Credits.

Response:

Attachment PUC 1-4 contains the requested information pertaining to subparts a. through e. of this request.

Regarding subparts f. through h., the Company does not own any renewable energy certificates (RECs) generated in the NEPOOL-GIS, and, therefore, did not apply to the NEPOOL-GIS for any net metered projects. However, upon registering the SOGs, the Company used the technology entered for PUC 1-4(b) for each project in Attachment PUC 1-4. To determine specifically as to how these projects are represented in NEPOOL-GIS, the Company would need to contact each project owner and request this information. Under the Net Metering Provision, the Company has no ability to force the project owners to provide the specific information they would have submitted to NEPOOL-GIS.

PUC 1-5

Request:

On Sheets 2-3 of the currently effective tariff and the proposed tariff, the definition of Eligible Net Metering System Site reads, in part, “a property owner may change the nature of the metered service at the delivery service accounts at the site to be master metered (as allowed by applicable state law) in the owner’s name, or become the customer of record for each of the delivery service accounts, provided that the owner becoming the customer of record actually owns the property at which the delivery service account is located.” This provision appears to be copied almost verbatim from the Net Metering Act (R.I. Gen. Laws § 39-26.4-2(6)).

- (a) Please define “master meter.”
- (b) What does it mean to change the nature of the metered service at the delivery service accounts?
- (c) Can the Company’s billing system produce an aggregate bill for multiple meters at a single location (i.e., apartment building).
- (d) Can the Company envision a scenario where each unit of an apartment building might have electric meters for each individual unit, but a single bill could be sent to the owner of the apartment building for purposes of administering the net metering program?
- (e) If the response to either (c) or (d) is in the affirmative, could an informational bill also be provided to the tenant of the individual unit to provide them with information about their usage?

Response:

- (a) A “master meter” is a single meter owned and maintained by the Company recording energy use from multiple units in a building or locations on the same property. The “master meter” would be used by the Company to determine overall billable consumption.
- (b) The tariff states that an “Eligible Net Metering System Site” can only include accounts with the same customer of record. This means that there can be one account (and one meter) or multiple accounts (and multiple meters) as long as all accounts are under the same customer. In this language, the tariff recognizes the right of a property owner to modify the property to be master metered (placing it under a single account with a single master meter) as long as state law allows it.

- (c) The Company's billing system typically produces a bill for a single account, with a single service point (associated with an electric rate), with a single meter. The Company's rate structures are designed for this typical scenario. In the past, the Company attempted to create a single "Summary" bill covering multiple "subordinate" accounts; however, due to the challenges associated with multiple billing cycles and customer confusion, the Company no longer offers this option. The Company's billing system is also capable of aggregating multiple meters into a single account within a single or multiple service point(s).
- (d) As described in the Company's response in part (c) above, this arrangement could be considered under a single account with either one or multiple service points. A solution that other developers use in the Company's Massachusetts footprint is for a property owner managing multiple accounts to set up a common web profile that organizes all of the accounts together. The individual accounts could be placed on auto-payment, and their bills could be placed on electronic delivery to a single email address.
- (e) In any scenario resulting in a single bill to the property owner, the Company cannot produce and deliver an "informational" bill for individually metered tenants. However, if accounts existed for each unit (as in a common web profile arrangement), each tenant could also set up their individual web profile to review their unit's bill online.

PUC 1-6

Request:

If the Company could provide an aggregate bill to the owner of the building under the definition of Eligible Net Metering System Site, what would be the additional cost to the Company of also providing unit specific informational bills to the tenants?

Response:

As stated in the Company's response to PUC 1-5(e), in any scenario resulting in a single bill to the property owner, the Company could not produce and deliver an informational bill for individually metered tenants. Sending separate informational bills would require the Company to designate an additional third-party on each account (an account relationship). These third-parties would then need their own bill delivery instructions (i.e., paper, electronic), and the bill print function would need to be modified to produce this separate bill. The ongoing cost would be the cost of generating another bill (e.g., \$0.47 for a paper bill, \$0.09 for an electronic bill). However, the Company would need to evaluate the one-time cost required to modify the system as described above using the Company's process for evaluating changes to its billing system. This process involves an examination of the scope of the project's requirements, required design, build, and related test to confirm that the changes work. As part of this process, the Company would have to create the specifications detailing the required changes to the system, confirm the time required to design, build, and test the changes, and estimate the costs required to complete this work.

The Company has not done such an evaluation. For this reason, setting up a web profile as described in PUC 1-5 (d) would likely be the simplest way for a property owner and tenant to see how net metering credits, if applicable, have been allocated on a monthly basis while also allowing tenants the ability to see their individual use.

PUC 1-7

Request:

Is the Company able to provide the number of master meters on residential units currently in The Narragansett Electric service territory? If so, please provide a list of the account locations, and if available, whether the tenants would be on the A-16 or A-60 rate.

Response:

The Company currently bills 575 master-metered electric customers as shown in Attachment PUC 1-7. This attachment includes information regarding the rate class for each customer. Fourteen accounts billed on a C06 rate are also included because there may be residential units served by those meters.

Request:

Due to the differences in measurement between community remote net metered facilities and traditional net metered facilities, will customers employing community remote net metering receive a different credit for one kWh of generation than if the same customer was employing traditional net metering?

Response:

Yes. Under the Company's Net Metering Provision, RIPUC No. 2169, the Company applies a Renewable Net Metering per kWh credit to every kWh generated by a remote generator up to 100% of the aggregate on-site use of the recipient accounts. The Renewable Net Metering per kWh credit is equal to the sum of the:

- (i) Standard Offer Service kilowatt-hour charge for the rate class applicable to the net metering customer;
- (ii) Distribution kilowatt-hour charge;
- (iii) Transmission kilowatt-hour charge; and
- (iv) Transition kilowatt-hour charge

The Company does not separately meter the on-site load of a traditional "behind-the-meter" net metering customer. Therefore, these customers are able to displace kWhs that would have been delivered by the Company with on-site generation at the full retail rate, which includes charges for energy efficiency and renewable energy programs.
