Verizon is engaged in a multi-year program to update select wire centers to all-fiber facilities including the **CT, RI, MA, NY, NJ, PA and VA** wire centers listed on **Attachment 1**. In order to complete this fiber initiative we plan to grandfather and eventually withdraw certain legacy PUC services that are provisioned over the existing copper infrastructure. Our records indicate you subscribe to one or more of these services found in **Attachment 2**.

On or after **January 15, 2020**, and subject to regulatory approval where required, Verizon will stop accepting new circuit requests for these services if they will originate or terminate in an Attachment 1 office. Circuit moves or changes will also be prohibited. Modifications in service offerings for customers with existing contracts are subject to the terms of their contract or of the tariff.

The timeframe to discontinue (i.e. disconnect) these services will depend on our schedule for fiber rollout in your area. We will provide you a future communication of those plans when finalized.

You may have received previous disconnection notifications for segments of this circuit at other locations. If you have a point-to-point service, the location with the earliest disconnection date will serve as the disconnection date for the entire point-to-point service.
