#### Good afternoon, Luly:

I am writing to submit National Grid's responses to the PUC's request for comments in Docket 5022 regarding the suspension of service terminations and certain collections activities during the COVID-19 emergency. National Grid responds to the PUC's questions as follows:

# <u>Question #1</u>: Have collections dropped off for nonresidential customers over the past two weeks compared to prior months and prior years?

<u>Response</u>: Yes. Collections have dropped off for nonresidential customers over the past two weeks compared to prior months and prior years.

#### Question #2: If so, please quantify the extent of the reduction.

<u>Response:</u> The reduction is \$3.1 million to \$2.8 million, which is a 10% reduction. The daily payment average is \$300,000 less per day. Please note that this decrease in payment is not solely attributable to the cessation of field terminations. There are other factors that may contribute to the decrease in cash receipts such as delays with the U.S. Postal service and the lock box service that is used to receive hard copy checks.

## **Question #3:** What effect has any such reduction had on the utility's cash flow?

Response: So far, the reduction in payments has not had any significant effect on the utility's cash flow.

<u>Question #4</u>: Has the utility been unable to meet any obligations, or does it expect to be unable to meet any financial obligations in the next two weeks if it cannot commence termination of service as a collections option.

<u>Response:</u> The Company has been able to meet its obligations and expects to be able to meet all its obligations in the next two weeks if it cannot commence termination of service as a collections option.

## <u>Question #5</u>: What activities is the Company planning for NON-residential customer collections activities (particularly service terminations) for the period March 31 through April 15?

<u>Response</u>: The company is planning to discontinue terminations on nonresidential accounts through April 15. The Company will evaluate the circumstances after April 15 and consider its options at that time.

#### Hi Cindy

I would like to make a correction to my previous email which including all classes not just the non-residential customers. Our overall collections was down 15 percent from a year ago and 12% from last month. Pascoag's customer base is 88% Residential, 11% Commercial and small commercial, and 1% industrial. For the non-residential the payment history has remained the same.

#### Given current conditions:

- 1. Does Pascoag believe it will have adequate cash flow to meet its financial obligations over the next:
  - a. 30 days? Yes, the District has adequate cash flow to meet all of its obligations.
  - b. 45 days? Yes, the District has adequate cash flow to meet all of its obligation
  - c. 60 days? It is too early to speculate, It will depend on the cash flow coming in. We continue to bill customers and are hopeful that they will continue to pay.
  - d. In responding, please comment on ability to meet payroll, other operating expense, debt obligations and purchased power obligations.
    - The District will be able to meet all obligations for at least 45 days, beyond that we feel it is too early to speculate.

- 2. What is the current balance in the Purchase Power Restricted Fund?

  The current balance in the Purchase Power Restricted Fund is \$561.911.
- 3. Does Pascoag believe it will need to withdraw from the PPRF in the next 30 or 60 days? It is too early to speculate, It will depend on the cash flow coming in.

  Ninety-seven percent of the payments for nonresidential customers were made.

- ii. If so, please quantify the extent of the reduction.
- iii. What effect has any such reduction had on the utility's cash flow?
- iv. Has the utility been unable to meet any obligations in the next two weeks if it cannot commence termination of service as a collection option.

In response to collections of customer's bills, SUEZ Rhode Island has not seen a drop off of payments at this time. For example the average collection over the last 10 days (3/11/20 to 3/24/20) was \$14,593/day, From 2/25/20 to 3/9/20 was \$14,957 and from 2/11/20 to 2/24/20 was \$14,780. This represents all customers as the Company does not track information by customer class.

SUEZ Rhode Island is part of the SUEZ family of companies and as such is part of a money pooling agreement with all of the regulated companies. As a result the Company does not foresee any issues with cash flow or paying its bills at this time.

Lastly, prior to the Commission's Order, the Company had discontinued shut-off procedures and will continue that until further notice.

We have a slight increase in past due amount for our non-resident accounts for March. The beginning of the month we were at 13% past due and as of today we are at 16%. This pattern is typical to prior years.

Approx. \$100,000 for March

What effect has any such reduction had on the utility's cash flow?

At this point in time we do not have a cash flow issue. Many of our customers make payments at very end of the month when they are do. Better data will

be available in the coming weeks. Our concern will be on water sales in future months specifically the impact on the summer season. Spending is limited

to essential purchases only in anticipation of reduced future water sales and receipts.

On behalf of the City of Woonsocket's Water Division these responses below are in response to the questions in the Commission's Notice:

## Question #1: Have collections dropped off for nonresidential customers over the past two weeks compared to prior months and prior years?

<u>Response</u>: Yes. Collections for our combined nonresidential and commercial accounts have dropped off over the past two weeks as compared to prior months and prior years.

#### Question #2: If so, please quantify the extent of the reduction.

<u>Response:</u> Based upon data that currently reflects a combination of residential and commercial accounts; combined our collections are 61% less than the same period in FY '19, and 54% less than the same period in FY '18.

#### Question #3: What effect has any such reduction had on the utility's cash flow?

<u>Response</u>: Any issues from any such reduction has little impact on the utilities cash flow. Fortunately Woonsocket has several cash restricted accounts with sufficient balances to meet a short term reduction in cash flows.

Question #4: Has the utility been unable to meet any obligations, or does it expect to be unable to meet any financial obligations in the next two weeks if it cannot commence termination of service as a collections option.

<u>Response:</u> No, the City has sufficient cash reserves to meet a short term reduction in cash flows. Woonsocket will be able to meet its financial obligations in the next two weeks.
