**NOTICE OF WITHDRAWAL OF  
PETITION TO CONVENE DISPUTE RESOLUTION PROCESS**

Pursuant to Rule 1.12(c) of the Rules of Practice and Procedure of the Rhode Island Public Utilities Commission (the “PUC”), Green Development, LLC and its affiliated entities, including GD Richmond Beaver River I, LLC, GD West Greenwich Nooseneck I, LLC, and GD West Greenwich Nooseneck II, LLC (collectively “Green Development”), hereby submit this Notice of Withdrawal of Petition to Convene Dispute Resolution Process (the “Petition”) instituting the referenced proceeding, Docket No. 5184. In support hereof, Green Development states as follows:

1. On or about August 13, 2021, Green Development filed the Petition with the PUC.
2. On or about October 15, 2021, Green Development terminated certain Interconnection Service Agreements implicated in the Petition.
3. Green has therefore resolved to withdraw the Petition.
4. No hearings have been held or convened in this matter.

For these reasons, and as permitted under Rule 1.12(c), Green Development provides notice to the PUC and all parties in the proceeding that it is withdrawing the Petition, without prejudice.
