**Minutes of Open Meeting Held on July 18, 2018 @ 3:00 P.M.**

An Open Meeting of the Public Utilities Commission was held on Wednesday, July 18, 2018 at 3:00 P.M. in Hearing Room A, 89 Jefferson Boulevard, Warwick, Rhode Island to discuss, deliberate and/or vote on the following dockets.

Present: Chairperson Margaret Curran, Commissioner Marion Gold, Commissioner Abigail Anthony, Cynthia Wilson-Frias, Linda George, Maggie Hogan, Alan Nault, Todd Bianco and Luly Massaro.

The Chairperson called the Open Meeting to order at 3:00 P.M. A quorum was present.

**Docket No. 4606 – Block Island Power Company** – Block Island Power submitted on July 2, 2018 a petition under Rhode Island Gen. Laws §39-1-2(26) requesting for a two-month extension, from August 1, 2018 to October 1, 2018, for the requirement to file a full rate filing. There being no objection filed, Chairperson Curran moved to grant an extension until October 1, 2018. Commissioner Anthony seconded the motion and the motion passed. **Vote 3-0.**

**Docket No. 4838 – Pascoag Utility District** – Pascoag Utility submitted on June 25, 2018 proposed tariff filing to implement an Arrearage Management Program and applicable tariff provision for effect July 25. Chairperson Curran moved to suspend the tariff filing so discovery can be continued. Commissioner Gold seconded the motion and the motion passed. **Vote 3-0.**

**Renewable Energy Eligibility Application Dockets** – The Commission reviewed the following applications submitted by RI Solar 1, LLC. PUC consultant submitted a summary of his review and recommendation that eligibility is granted with a conditional requirement that the Company provide documentation verifying Commercial Operation and that the Company provide evidence of the Generation Unit’s NEPOOL-GIS Asset Identification Number. After review, Chairperson Curran moved to approved the applications with the PUC consultant’s recommendation. Commissioner Gold seconded the motion and the motion passed. **Vote 3-0.**

- **Docket No. 4828 – RI Solar 1, LLC’s** application for eligibility certification of the RI Solar 1, LLC (Plat 4 Lot 2 Glen Rock Road) generation unit, a 0.216 MW AC (0.24948 MW DC) solar facility located in West Kingstown, Rhode Island, as a New Renewable Energy Resource.
- **Docket No. 4829 - RI Solar 1, LLC’s** application for eligibility certification of the RI Solar 1, LLC (500 Waites Corner Road) generation unit, a 0.216 MW AC (0.24948 MW DC) solar facility located in West Kingstown, Rhode Island, as a New Renewable Energy Resource.

- **Docket No. 4830 – RI Solar 1, LLC’s** application for eligibility certification of the RI Solar 1, LLC (849 Victory Highway) generation unit, a 0.216 MW AC (0.24948 MW DC) solar facility located in Coventry, Rhode Island, as a New Renewable Energy Resource.
- **Docket No. 4832 - RI Solar 1, LLC’s** application for eligibility certification of the RI Solar 1, LLC (15 James Road) generation unit, a 0.216 MW AC (0.24948 MW DC) solar facility located in Hopkinton, Rhode Island, as a New Renewable Energy Resource.
- **Docket No. 4833 - RI Solar 1, LLC’s** application for eligibility certification of the RI Solar 1, LLC (Plat 14 Lot 1 Fairgrounds Road) generation unit, a 0.216 MW AC (0.24948 MW DC) solar facility located in West Kingstown, Rhode Island, as a New Renewable Energy Resource.

**Clearview Electric, Inc’s (Clearview) Motion for Use of \$7,106 [New] RECS for Rhode Island 2017 [RES] Compliance** – After review and consideration, Chairperson Curran moved to approve Clearview July 12, 2018 motion that it be allowed use of 7,106 Class 1 RECs inadvertently retired in Connecticut toward its Rhode Island 2017 compliance subject to the requirement that the 7,106 Class 1 RECs were not included in the accounting of Clearview’s Renewable Portfolio Standard compliance in Connecticut. Clearview shall provide evidence that the Connecticut Public Utilities Regulatory Authority (PURA) approved Clearview’s to use the 7,106 Class 1 RECs for Rhode Island compliance purposes and that they were not used toward Clearview’s Connecticut compliance. Commissioner Anthony seconded the motion and the motion passed. **Vote 3-0.**
